2. Payment: A 50% deposit will be required to reserve your spot on our trip to Oaxaca. The full balance must be received no later than 45 days prior to the start date of your trip. For reference, the trip start date is October 4, 2024; the full balance will be due no later than August 20, 2024.
3. Insurance and cancellations: A travel insurance policy is not included with the purchase of your trip. We recommend purchasing a travel insurance policy to account for any last minute changes or cancellations. If you choose not to purchase trip insurance we can not guarantee a full refund as it will be dependent on our ability to fill your spot on the trip.
4. Special Requests, medical problems, and disabilities: If you or anyone in your party has any medical problem, disability, allergy, or special request, please notify us prior to making your deposit. This trip includes physical activity and culinary exploration. If you have limiting medical conditions or allergies, we will make our best effort to provide alternate activities and food to accommodate your needs. If we are unable to accommodate to your needs, we will not be able to accept your deposit. If you advise us of these needs after your deposit and we are unable to accommodate we will be required to treat your trip as cancelled.
